

Qualitative research using photo-elicitation to explore the role of food in family relationships a

Abstract

Obesity in adolescence is a major public health issue. Family relationships have an important role, whether in the onset of the condition, its maintenance, or the way in which the problem is approached. Food and family relationships are two major elements in therapeutic care. The subject of the present study is the investigation of the place of food within family relationships among obese adolescents, so as to tailor care strategies. Twelve semi-structured interviews were conducted among adolescents presenting obesity and their parents. The investigation was qualitative, and used photo-elicitation. A photograph produced by the subject is used as the basis for narrative, and the verbal material obtained is analysed using Interpretative Phenomenological Analysis. The results can be categorised along two axes. The first describes the place of food in the one-to-one parent-child relationship ; the second describes the organisation of the family group. This study evidenced two possible lines of approach in understanding the place of food in these families. There are major interrelations between food and relationships within the family, so that implications for therapy can be drawn: taking account of bonding between parent and child, and therapeutic orientation towards family functioning rather than towards individual eating patterns.

ABSTRACT

Obesity in adolescence is a major public health issue. Family relationships have an important role, whether in the onset of the condition, its maintenance, or the way in which the problem is approached. Food and family relationships are two major elements in therapeutic care. INTRODUCTION

Obesity prevention is a major public health issue in numerous countries all over the world. Prevalence rates are high, and have increased regularly over at least the last two decades. The number of obese individuals was estimated to be 500 million worldwide in 2005 by WHO (World Health Organization, 2011). Obesity now affects children, with constantly increasing numbers over recent years. It is thought that there are around 110 million children worldwide who are overweight or obese (Caprio et al., 2008). In the USA, childhood obesity has more than doubled in the last 30 years. Recent figures estimate this prevalence to be 11.9% (Ogden, Carroll, Curtin, Lamb, & Flegal, 2010). The consequences of obesity are well-known. They are orthopaedic, neurological, pulmonary, hepatic, endocrine, and cardio-vascular (Reilly & Kelly, 2011; Schwimmer et al., 2006).

Classically, the treatment of obesity has been based on altering behaviours, diet, and the amount of exercise (Doak, Visscher, Renders, & Seidell, 2006). This type of treatment is questioned today, following results that often proved positive in the short term, but not very efficient in maintaining the weight in the longer term (Murtagh, Dixey, & Rudolf, 2006; Oude Luttikhuis et al., 2009). The importance of the involvement by parents in the care process is increasingly highlighted in recent studies and recommendations (Chapman & Ogden, 2009; Lindelof, Nielsen, & Pedersen, 2010; Müller & Danielzik, 2007; Murtagh et al., 2006; Oude Luttikhuis et al., 2009; Shrewsbury et al., 2010; Thompson & Thomas, 2000). The parents create the eating and dietary environment of the child, and influence dietary behaviours and choices (Birch & Davison, 2001). Excessive restrictions imposed by parents on access to high-calory

foods could for instance be associated with an increase in high-calory intake, and consequent weight increase (Kral & Rauh, 2010). Other factors such as the influence of parental dietary preferences, structured family meals, single-parenthood (less time spent preparing meals), and eating meals outside the home (Patrick & Nicklas, 2005), or again the degree of family cohesion, could also influence BMI in childhood and adolescence. (Berge, 2009). Among children and adolescents the notion of dieting implicates the parents in a role of accompaniment and control, but this also requires a reappraisal by parents of their own beliefs and behaviours in the area of food. Certain authors claim that food plays a part within familial interactions, and that failing to take this into account could be a factor for therapeutic inefficacy (Wong, 2010). Others emphasise the need to take account of family issues in the treatment of these patients (Murtagh et al., 2006; Shrewsbury et al., 2010). Most specialists in this area seem unanimous on the need to implicate the family in the care strategy, although the mechanisms involved have not been evidenced. Understanding some of these mechanisms could enable the adaptation of care provision to each family, targeting the dysfunctioning areas. The question of the position and the role of food in family relationships is therefore central both to the understanding of obesity among adolescents, and to the way in which they are cared for. This is the theme of the present research. This research was developed in the QUALIGRAMH group. This multidisciplinary group comprises researchers, physicians, and psychologists specialised in the area of adolescence. Its aim is to develop qualitative research in adolescent psychiatry.

A qualitative methodology was implemented, using a tool known as photo-elicitation for the first time in psychiatric research. Qualitative methods are expanding fast in medical research. They are particularly suited to research in the field of psychiatry,

where patient perspectives are central in both diagnosis and treatment (Revah-Levy, Birmaher, Gasquet, & Falissard, 2007; Taïeb, Révah-Lévy, Moro, & Baubet, 2008).

This photo-elicitation tool is a Visual Narrative method (Harper, 2005; Rose, 2006) that is already well-known in the social sciences. We chose a visual narrative method on account of the difficulty experienced by obese adolescents encountered in our clinical practice in putting issues of food and family relationships into words. The intention was to use a method that would facilitate verbalisation. Photo-elicitation consists in using one or several photographs taken by the subject as the basis of the interview. Among adolescents, photo-elicitation enables greater implication in the subject studied, greater control over discourse, easier verbalisation of difficult or complex concepts, and an alleviation of the hierarchical relationship with the adult investigator (Guillemin & Drew, 2010; Owen, Duncan, & Sawyer, 2010). The photograph is used as a mediator in the interview, facilitating verbal exchanges, recollection, and the expression of experience. It however remains a mere tool, and is not analysed for itself. The photo-elicitation method has rarely been used to date in clinical research. It has been used for instance to study pain, quality of life, the experience of chronic illness in children, or dietary choices (for example see (Hanna & Jacobs, 1993; Hanna, Jacobs, & Guthrie, 1995; Johnson, Sharkey, McIntosh, & Dean, 2010; Lassetter, Mandleco, & Roper, 2007). To our knowledge it has hitherto never been used in psychiatric research.

For the construction of the interview grid and the analysis of data we used the Interpretative Phenomenological Analysis (IPA) method, an established qualitative methodology used to explore in depth how individuals perceive particular situations they are facing and how they are making sense of their personal and social world (Smith, 1996). The approach is phenomenological, in that it involves a detailed

exploration of participants' experiences. The aim is to explore personal experience, and the subjective perception of an object or event. Rather than reducing a phenomenon to a number or an identifiable variable, and controlling the setting in which the phenomenon is studied, phenomenology aims to describe it as faithfully as possible, with the setting in which it occurs (Smith, 2008).

This article aims to explore how family and food interact, what place food occupies in family relationships among obese adolescents, what the issues are, and what adaptations can be suggested for the complex care strategies in this pathology. The specific nature of the method also afforded the opportunity to experiment with the use of the photograph as a research medium, facilitating access to data and its collection.

METHODS

Sampling and Participants

Sampling in qualitative research involves purposive sampling of individuals liable to provide the most informative description of the phenomenon under study (Mays, 2000). Our sampling technique was of indeed purposive, because we opted for selecting subjects that were typical of the population of interest (Patton, 2002). A collegiate decision involving the investigators and specialised clinicians taking part in the research enabled the identification of adolescents and their parents as the most likely informants, since they are the actors in the family relationship. The size of the sample was determined by data saturation.

Adolescents with obesity fulfilling the Cole et al. criteria (Cole, 2000), and whose first language was French – this being required for in-depth interviews - were recruited consecutively from the Department of Adolescent Care of Cochin Hospital in Paris, and from the Romagnat Mother and Child Care Centre, France. The adolescents were aged from 12 to 18. Participation in this study was proposed by the reference physician in of the health facility concerned, and study information sheets were provided to all potential participants and their parents. This research received approval from the Ethical Review Committee (*Comite d'évaluation de l'éthique des projets de recherche biomédicale (CEERB) du GHU Nord*), Paris, France. According to the declaration of Helsinki, written informed consent was obtained from all patients included in the study before interview. As they were all minors, consent of their parents was also obtained. Seven adolescents were included in the study. The study was also submitted to the parents, and five parents agreed to be interviewed. Thus the study material was derived from twelve interviews.

Data Collection

The present study was conducted by way of semi-structured interviews, with photo elicitation tool. The photograph is provided by the subject, and used as the basis for the interview, enabling the verbal material to be steered and also enriched.

Preliminary interviews were conducted with the adolescents to facilitate contact during the recorded interview, and familiarise them with the research. These consisted in a first contact, a description of the way the research was to be conducted and its subject,

collection of socio-demographic data and written informed consent. Following this interview, the young people were provided with a disposable digital camera and asked to take a photograph with the following instructions:

"We want you to take a photograph of the table after a family meal. It should be taken before the table is cleared. There should not be anyone visible in the photograph which means you should take it after the people at the meal have left the table. You can take as many pictures as you like, but in the end you will choose just one to comment on with the researcher in the interview".

The cameras were mostly issued to the young participants at the time of recruitment, following socio-demographic data collection and informed consent. The picture taken by each adolescent, displayed on a computer screen, formed the basis of individual interviews, which took place as soon as possible following receipt of the camera. Separate interviews were conducted with adolescents and parents. As required by the ethics committee, the photographs were neither published nor stored.

The interviews were semi-structured, with an open-ended approach: the investigators had a set of questions on an interview schedule (Table 1), but at the same time, there was an endeavor to enter the psychological and social world of the respondents. The idea was that respondents consequently shared more closely in the direction taken by the interview, and could introduce an issue that investigators had not thought of. Respondents were viewed as experiential experts on the subject and were allowed the opportunity to tell their own story. This form of interview facilitates empathy, allows flexibility of coverage and discovery of novel areas, and it tends to produce richer data.

The investigators were free to probe interesting areas that arose and they could follow respondents' interests or concerns. [Table 1]

The interviews started with description of and commentary on the meal photographed, and then went on to the way in which the meal unfolded generally, relationships with food, and the use of food in family relationships.

The interviews took place in a room in the adolescent's research unit in Cochin Hospital, Paris or in Romagnat Mother and Child Care Centre (near Clermont Ferrand, France). Each interview lasted one to one and a half hour. The adolescent was interviewed first. The second interview with the parent was performed either immediately afterwards, or in the few days following.

All the interviews were conducted by the same researcher (JL), between January and July, 2011. The interview sheets were rendered anonymous.

Analysis

All interviews were audio-recorded with participants' permission, transcribed verbatim in French and analysed using IPA, with word-processing and spreadsheet software.

The first stage of the analysis involved interviewers checking the transcripts for accuracy against tape recordings. Individual transcripts were repeatedly read, and then coded to identify initial themes, which were annotated in margins. This was close to being a free textual analysis. Each reading had the potential to bring up new insights. Recurrent themes (Morse & Field, 1995) were then identified across transcripts; recurrent themes reflect a shared understanding of the phenomena in question among

participants. This stage involved a more analytical ordering, as researchers tried to make sense of the connections between themes. Some of the themes tended to cluster. The process was dynamic and cyclic, with each transcript leading to the collection of further data and to their subsequent analysis. The aim was to recognize ways in which narratives from the participants could be similar but also different. Researchers were in fact disciplined to discern returning patterns, but they also integrated new issues emerging, so as to take account of convergences and divergences in the data. The last stage was to produce a coherent ordered table of the themes (Smith, 2008). The procedure for data analysis was inductive as the analysis of data from the literature was performed secondarily.

To enhance validity, a single researcher (JL) carried out the main analysis, and transcripts were also read by two other researchers (ARL and OT) to improve consistency and coherence of analysis by ensuring that the theme identified were an accurate reflection of the data and that the analysis was not confined to one perspective. The results were discussed in repeated meetings with this research team. These discussions helped to highlight necessary clarifications or modifications among the themes identified. Another way of enhancing validity was also the care taken to distinguish clearly between what respondents said and researchers' interpretations or account of it (Smith, 2008). In the results below, extracts of respondents' verbatim account have been chosen as exemplifying the underlying recurrent themes. In order to protect confidentiality, identifying information has been removed in the quotes presented.

The verbatim account has been freely translated into English for the sole purposes of the present article, the main objective of the translation being to preserve the essential

meaning and content, and as far as possible general tone. For greater clarity, certain words have been added in square brackets. Three dots represent a pause in the utterance. Three dots in brackets mean that part of the sentence has been deleted.

RESULTS

Seven families were recruited for the study, and twelve interviews were conducted: three boys aged 12, 13 and 16, four girls aged 13, 14, 15 and 18, four mothers and one father. Their characteristics are summed up in table 2. Three of the adolescents had separated parents; the themes identified did not differ. The analysis of these interviews enabled saturation of data to be achieved across the sample [Table 2].

The phenomenological thematic analysis of the interviews yielded seven main themes found both in the adolescent interviews and in those of the mothers. From these themes and their cross-sectional nature we defined two axes of experience, which are in fact two relational modes: the first explores the place of food in the one-to-one parent-child relationship, the second explores the place of food in the functioning of the family group. The themes identified in the interviews with the mothers were also found in the interview with the one father. We have therefore presented them together without differentiation. The various themes are presented in table 3. [Table 3]

The one-to-one relationship

Food as a means to express love

Expressing love through food was common among parents. Food was a means to express nurturance, and parents in particular, who were the nurturers, tended to express their nurturance, and their love, through food:

Mother 2 "Getting [them] meals is like a big cuddle"

Serving food and receiving food bonded the giver and receiver in the family context in all the families. Their relationship was tied to food, as food was important in the relationship. Most parents who are used to offering food find withdrawal of food difficult, because putting a child on a diet will result in a disruption of the bonding between them and the child, and a fading of their influence in the eyes of the child and in the family:

Mother 4 "That meant that [my daughter] could question my role as a parent, or at least my parental affection. In the sense that if you don't feed me, then you don't love me. She may have actually said that, that [refusing food] is not a normal state of affairs, that a mother should make meals for her child"

The loving relationship is not a process whereby there is an active agent supplying a passive agent who receives, it is an exchange and has a relational dimension. Thus if a mother deprives her child of food, the child can interpret this as a breakdown of the loving relationship. In the other direction, the receiver must accept the food, it is part of the implicit contract in the relationship. The way the nurturer prepares meals is recognised, and imposes the eating of the meal. Even when a dish is not to his/her taste, the receiver forces him/herself to return the proof of love, to give pleasure.

Girl 3 "She has a way of seasoning things that makes me eat them".

Interviewer "Do your parents sometimes make food you don't like?"

Girl 7 "Sometimes I force myself, like when they make [the same thing] several times"

Controlling the relationship with food

In the same manner as love, issues of power in the relationship are played out in food. The parents or the adolescent may impose, oppose, or refuse. These positions are constantly re-negotiated, in a struggle for power.

Mother 5 "She was gulping everything down, so in the end I found a system, using a bowl for the two of us, and no more"

Interviewer "How do you react when she refuses to eat what you offer her?"

Father 7 "Well, I suppose... you can react in several different ways. In that case... how can I explain it... forcing her, in a way, I suppose. Promising rewards, too, I must admit. And getting angry. Getting angry and...and then in the end saying "so what, forget it". And after that it's true you regret it. When she says, no I'd rather have potatoes and you give her potatoes, that is to say...you think no, it's not good for her".

Controlling food represents a much wider take-over of control. Each protagonist expresses his or her claims through food, sometimes explicitly, sometimes implicitly:

Girl 4 "Even if I'm not hungry, I tell Mum "I'm hungry". But saying I'm hungry doesn't mean I'm really hungry, it really means "I'm fed up with eating the same thing". So what I get from her is... "you should eat a variety of foods". Or else "Go and do the shopping yourself". Or ... whatever!!"

The adolescents' behaviours oscillate between active opposition and resignation towards parental domination. What they said varied in the course of the same interview, depending on the situation described. Thus the power trade-off seemed to balance itself out so that the two parties accepted the relationship.

Boy 6 "And anyway I won't eat it if I don't like it, so it's not even worth talking about"

Interviewer "And in your mother's place, who decides?"

Boy 6 "It's just about always my mother. Well, often she does ask me, but most of the time I don't really know, so she decides"

The regulation of presence and absence of the parent by way of food

Here the issue is to determine if food can be used to regulate absence or presence in family life, whether in terms of too much, or of too little. The meal can materialise the absence of the parent, or more exactly the imposed absence of the parent. The adolescent eats frugally, on his own, a rather unbalanced meal, simple and quick to prepare, snacking.

Boy 1 "In the morning, and sometimes in the evenings, when I don't know what to do, or... well, when I'm on my own, or... I get myself a milky coffee. It tends to be... in the week, when I'm alone in the evening, and my father is travelling and my mother gets home late".

The meal however fills in for absence. Food is then used as a parental substitute. It compensates for an affective deficiency, it fills a vacuum.

Mother 4 "And maybe, too, the fact that she's on her own, she needs to fill in the gap. At any rate that's more or less what she tells me (...) I have given her all I could, but I

was not always really available. So I think she... maybe she compensated with food, in a way".

Food and meals can also symbolise presence. The meals served are prepared, elaborate, and often copious.

Mother 5 "Well, on Sundays, when she... when the time is right, we invite my other daughter, who is 34, her partner and all that, and we have a really good meal (...) We take trouble cooking it. So we have it on the table in the dining room. On Sundays we use the dining room, we try to do something a bit more elaborate".

Certain parents, finally, use food to demonstrate their presence. These trends are shown up first of all among the parents interviewed, by way of endless lists, repetitions, superlatives when they talk about food, as if the aim was to live up to some standard, to reinforce their presence. Food in their very discourse symbolises a strong presence.

Mother 1 "Well as for his habits... for him for example it's eating dried fruit, dried fruit, at breakfast, in the evening, you see it keeps him occupied after the meal. He eats dried fruit, dried fruit, and he eats a lot of fruit and vegetables. Every day, every day, every day, every day... Every day he eats fruit and – fruit. Well, apples, oranges, mandarines"

The use of food as an attempt to set a distance in the parent-child relationship

This fourth theme is also linked to the notion of presence: it concerns the management of the relational distance, of close proximity, and the removal of distance. Here we find a marked closeness between parent and child, and food being used as a way to draw

away from this relationship. It is an attempt to put a distance, where there is too close a relationship. Food is used as a third party in the parent-child relationship.

This relational mode is often directional, that is to say it is the parent who clings to the child, and the child who uses food as a means of escaping the parent's embrace. The adolescent avoids the presence of the parent, and family meals where relational issues are played out. Here the family meal becomes the symbol of this over-close relationship.

Girl 5 "I have already lied to them, saying that I was doing something, so as not to eat with them, you see. It's happened no end of times (...) I say to myself, hurry up and finish eating, so you can get away".

Girl 4 "When things don't go well, either it's me who is tired, or I've had a bad day, or else Mum is tired or has had a bad day, and then, well, we're both a bit tense. As soon as one does something wrong the other points it out, we get annoyed, and then... we have the meal, but... Generally I refuse to eat, and so I go off and do something else in my room... And Mum gets her meal and eats it in the sitting room, or does something else".

This third-party function allocated to food is one way among others for the adolescent to try to separate from the parent. It is interesting to note that this type of behaviour is not often deployed by the parent.

Mother 2 "A plate, chips, and that's it! Two glasses of coke, the remote control... it's true that TV comes between us two quite a lot"

Certain parents, in the same way as the adolescents, use food as a means to draw away. For them it is a mediation tool, to remove the affective charge from the one-to-one relationship.

Mother 4 "Sometimes it's... a way of talking about more complicated things (...) It makes things easier, because there is a nice meal, something she likes, and we can enter into important conversation (...) It's a time of sharing, it's liable to be easier than when we are at home just the two of us".

The functioning of the family group

The meal as a moment of family cohesion

The meal is often described as a moment of cohesion, sharing and communication: the family eat, they talk, a flow of words and food. The family group forms and unifies around the mealtime. Cohesion is generated by the fact of eating together. For the parents it is an integral part of the pleasure of eating.

Mother 1 "Getting together?... it's better if we eat together. It's a time for being, otherwise each of us would be living apart, wouldn't we? Yes, it's a moment of togetherness, no, it's... and even so, there are exchanges, often..."

However the apparent cohesion appears fragile. Even if the parents express pleasure in having meals together, in the setting of daily mealtimes there are situations in which the encounter does not occur. When the conflict is too strong, the family may establish by-pass strategies: television, reading, or even separation. In these instances the meal reinforces or symbolises the conflict.

Girl 4 "Because in general when things aren't going well, I have my meal in my room and she has hers in the living room"

Interviewer "So when things are calm, is when you get along together and talk"

Girl 4 "And have our meals together."

The meal becomes the scene of a struggle, very far removed from the ideal of unity that it might suggest.

Girl 5 "We don't talk, there's not much communication, so... there it is (...) Well I know it's me too, I don't do all I should, well... I don't really want to talk about it. And... it's during meals especially, because in fact... I feel impatient at sitting at the table, eating with the others".

The transmission of the family history

Through eating styles and patterns, each person expresses a part of himself, his culture, his history and his ways of being and doing.

Handing down what one has received is a way of remembering, and of finding one's place in one's own history.

Mother 1 "I think it's a way, too, of keeping up ties with [my parents] (...) It's as if... well as if they were still here".

The transmission is explicit for the parents, and often implicit for the adolescent, who learns by watching, sharing and imitating. When the conflict is too great, the transmission may not occur at all:

Girl 5 "I've never really done much, in the way of cooking, with my mother"

Interviewer "Is cooking her job?"

Girl 5 Yes, that's it. And anyway I think I would get impatient pretty quickly, yes, it would get on my nerves".

The staging of the meal as an indicator of family organisation

In the discourse of both adults and adolescents it is possible to see the rules, the distribution of tasks, and the organisation of the meal from its preparation to its completion. The "staging" of the meal appears to provide information on the "staging" of the family itself, its structure, and its relational patterns. When a family is completely de-structured, meals are often organised in very chaotic manner. For instance in his interview one boy described a destructured family in which no-one was in his or her right place, and in which there was a general impression of confusion as to the roles of the different actors. This confusion is clear when he describes the meals:

Interviewer "When do you generally eat?"

Boy 2 "Oh, it's... it can... there's no particular time (...) Often we eat sitting on the sofa, on the sofa in front of the TV in fact. It's when we've invited someone, really, that we have meals at the table. And sometimes I have my meal while I'm on the computer."

Certain adolescents do not hesitate to question the family model. By calling for rules and habits in connection with meals, they question family relationships and organisation.

Mother 4 "[My daughter] has to have her three meals (...) For her, it's important to eat three times a day. So much so that she can even question my role as a parent".

DISCUSSION

The aim of the present research was to explore the place of food in family relationships among obese adolescents, using an original qualitative method, photo-elicitation. Two levels of response and understanding were obtained.

The first level concerns the family group, how food circulates, how it is managed, and how this stages the structuring of the family (cohesion, organisation, disorganisation). The results show the degree to which the meal is a moment of family cohesion, sharing, and joining together of the family around the meal table, and this theme has been noted in numerous studies (Carrigan, Szmigin, & Leek, 2006; Walsh & Nelson, 2010). The organisation of meals is a space for expression of family cohesion and structuring.

Current care provision for obesity puts emphasis on correcting the de-structuring of meals: subjects' diets are indeed frequently described as anarchical in this pathology. The obese adolescent eats sitting in front of the television (Dennison, Erb, & Jenkins, 2002) and snacks between meals (Sleddens, Kremers, De Vries, & Thijs, 2010). Numerous care protocols therefore emphasise the need for dietary education. Yet our interviews cast new light on these issues. It appears that the eating patterns in these families may be the expression of the family relational organisation. Both the adolescents and their parents, in the way they organise meals, appear to play out the distribution of roles and tasks, the conflicts, and the absence or presence of structure in

the family. It therefore appears essential to put the structure of meals in perspective with the structuring of the family in any therapeutic care plan.

The second level of understanding concerns the place of food in the interactions between parent and child: food as a means of expressing love, food in the control of the relationship, and - an original result of this study - food in managing the relational distance on the one hand, and presence or absence on the other.

Food as a means of expressing love and food to control of the relationship are themes that have been widely broached in the literature. The link between the person who feeds and the person who is fed in childhood, mingling love, control and mutual dependency, is particularly strong here. This notion is found in very different schools of thought, for instance in psycho-analysis (Winnicott, 1957) and also in systemic theories (Minuchin, Rosman, & Baker, 1978) and attachment theories (Hochschild, 1998). Thus the act of feeding or nurturing is considered by certain authors as a gift of self (Cappellini, 2009) enabling the establishment of one-to-one loving relationship (L. Kaufman & Karpati, 2007). There is reciprocity in this nurturing process: by nurturing, the parent proves his or her love, and by accepting the child also proves his love (Wong, 2010). It is indeed a one-to-one relationship of co-dependency, and this leads to a power struggle within the relationship. The power exercised is questioned by the child, and the parents may use food as a means of controlling the child (Olsen, 2008). The notions of loyalty, alliance, and betrayal are at the forefront (Wong, 2010). The power conflict is enhanced in adolescence, when aspirations for greater autonomy are stronger (Bassett, Chapman, & Beagan, 2008; Shrewsbury et al., 2010). Our results mainly evidence these patterns of

co-dependency and relational control. The implication of obesity in these phenomena is open to question. Dietary control and restrictions could infiltrate parent-child relationships, and the nurturing parent could feel responsible for the satisfactory progress of the care plan, while the adolescent might be torn between submitting to the requirement for dietary control and a refusal of the power status of the adult.

Again on the subject of the dual relationship, our study evidences a result that has hitherto not been reported in the literature, and that is how food is used in an attempt to distance another person, and to regulate presence and absence. In each nurturer/nurtured dyad, there is a period of extreme mother-infant closeness in early childhood (Hochschild, 1998; Winnicott, 1957). This relational pattern is found in our parent-adolescent dyads. Bruch (1974) showed a one-to-one relationship from which the father is removed (Bruch, 1974). But beyond this, it appears here that the adolescent uses food to manage the relational distance, to keep the parent at a distance and escape the over-close relationship. Food is a way of escaping the mother's embrace. However not only is food unsuited to this purpose, it in fact strengthens the bond even further. Overweight creates an even greater dependency towards the nurturing parent. Dependency leads to even wider use of this mechanism. Thus a circularity appears, in which the race towards "ever more" seems unavoidable. The strategy established fails.

The transmission theme concerns both the dyad and the group. It is partially broached by the present study, and is centred on sharing tastes and skills. This pattern is not specific to obesity, and food as a vector for transmission has been widely explored in the literature, particularly in relation to the cultural context. What is transmitted, and its

quality, varies according to the situation, the importance allocated to different things, and the cultural setting (Carrigan et al., 2006; Latreille & Ouelette, 2008; Moro, 2004). The impact of the cultural environment in relation to food and family relationships is a dimension that has not been explored here, and which will be studied in future research, since the project is to continue in sites in China, Chile and Canada.

This study has shown the usefulness of the photo-elicitation method, an original contribution in adolescent psychiatry. The method facilitated narrative, but above all enabled the collection of very valuable material. Further to this, we have obtained indicators in the understanding of obese adolescents in their family environments. Major interrelations seem to exist between relationships with food and relationships within the family, whether from an inter-subjective or a group perspective.

It is already possible to surmise therapeutic implications: more attention should be paid to bonding between parents and child, to any questioning of the nurturer-nurtured functioning (which should be accompanied), and to the drawing-away process in relation to food. Therapies should focus on family functioning rather than on individual dietary functioning. Instead of pinpointing anarchy in meal patterns, it thus appears more beneficial to accompany the family in a restructuring process so as to reorganise meals, help them manage relationships, conflicts, communication, and the role of each person.

The main limitation of our study is the difficulty in differentiating between what in the results is specific to the pathological condition of obesity, and what is more related to

adolescence (for instance the questions of control and autonomy are central in adolescence (Bassett et al., 2008)). The QUALIGRAMH study using the same methodology includes adolescents with anorexia nervosa alongside adolescents without any eating disorder, so as to apprehend what is specific to each situation.

The second limitation of the study is that there was only one father in the parental sample. The results for his father were similar to those obtained for the mothers. However more fathers need to be recruited to study any parental differences in positioning. It should also be noted that the place of the mother-child relationship is central, in Western societies, in the organisation of nurturing functions. Further research in a multi-site recruitment setting at present underway should enable exploration of this central position in relation to culture. More widely, light will be cast on all our results in a cultural perspective.
